- Places can only be secured upon receipt of payment. The fee must be paid 14 days before the course date. Late payment carries the risk of the course being fully subscribed and the provisional booking thereby being cancelled.
- If full payment has not been received by one month after the date of the training then an administrative charge of 10% of the total fee will be added.

Cancellation by clients

- harm-ed must receive notification of cancellation up to 14 days before the course date

- refunds are subject to a £15 administrative charge
